A Family's Story

Discovering our child's dyslexia in winter of 2020 was pivotal for our family. Finding the Stern Center in summer of 2021 had a profoundly positive impact on her academic journey and personal growth.

When we first learned about our child's dyslexia, she needed immediate support before entering 4th grade. The Stern Center provided the specialized help she needed.... Building Strong Kindergarten Foundations

In the heart of Vermont, a new initiative has begun to transform the educational journey of young children as they prepare to step into kindergarten. Teaming up with early educators who recognize a critical need, this project in collaboration with Head Start deepens preschool teachers' knowledge while screening young learners to identify the ways their early learning play can target language and learning development for future reading success.

The Stern Center's **Reading Readiness Check-Up** was devised to follow the hierarchy of skills acquisition outlined in the Common Core State Standards for kindergarten. The goal is clear: to ensure that all children enter kindergarten playfully interacting with language, knowing their letter sounds, finding joy in learning, and ready to read.

In its first year, the initiative has reached the Capstone Head Start programs in Barre at the Learning Together Center, in Morristown at the Lamoille County Early Learning Center; and at Head Start Collaborative Classrooms in Northfield, Williamstown, and Washington Village.

Teachers as Learners





A Teacher's Success: Meet Erika Monaghan



A Visionary Philanthropist:

Sinclair Sherrill's Commitment to Advancing Literacy with the Stern Center

SINCLAIR SHERRILL is the co-founder with Sebastian Scripps of Boon, a nationwide education nonprofit. A seasoned nonprofit leader and consultant with over forty years of grant making, fundraising, and board governance experience, Mr. Sherrill became associated with the Stern Center in 2011 through his focus on helping to solve the reading crisis in the U.S. Since then, he has become a steadfast philanthropic partner with the Stern Center, helping raise nearly \$1M to support our shared mission.

In 2018, Mr. Sherrill established Boon Philanthropy with the specific goal of identifying and implementing comprehensive philanthropic solutions to reduce the inequities in America's reading crisis by raising and distributing private funding for individual teacher training scholarships and free tutoring for low income and minority students in structured literacy, grounded in the science of reading. For decades, Mr. Sherrill has been a director and grant maker at a family foundation supporting fields such as education, literacy, and learning disabilities. He received his BA at Harvard University, and a juris doctorate from the University of Puget Sound/Seattle University School of Law. He is an honorary member of the American Academy of Pediatrics.

As Stern Center President Laurie Quinn describes it, "The Stern Center's partnership with Sinclair Sherrill has affirmed our purpose, broadened our reach, and strengthened our organization. He continues to be a treasured friend to our mission."






Haviland Smith, Jr. (1929-2024)


Lili Ruane (1959-2024)

Shared History, National Impact: Meet Dr. Reid Lyon

G. Reid Lyon, Ph.D., was the Stern Center's first **research director** when Dr. Blanche Podhajski founded the Stern Center in 1983. An Honorary member of the Stern Center Board of Directors, he has remained a supporter. Reid was featured in the award-winning podcast series Sold a Story in 2022-23.

Dr. Lyon received his doctorate from the University of New Mexico in neuropsychology and learning disorders, and is a distinguished scientist emeritus of neuroscience and cognition at the University of Texas, Dallas and a distinguished professor emeritus of Educational Leadership and associate dean at Southern Methodist University. He served as chief of the Child Development and Behavior Branch of the NICHD at the National Institutes of Health and was also an advisor to the Clinton and Bush Administrations on the development of evidence-based education policy, contributing to initiatives such as the National Reading Panel and the Reading Excellence Act.

Dr. Lyon has published hundreds of peer-reviewed journal articles, books, and book chapters, and has received numerous recognitions for his work, including the International Dyslexia Association's Samuel Torrey Orton Award for vital contributions to dyslexia research.
